North Fork Coeur d'Alene River Watershed Advisory Group January 26, 2017

This handout was prepared to share information about unassessed streams in the North Fork Coeur d'Alene River Subbasin and to obtain input from the Watershed Advisory Group regarding assessments.

Summary of Unassessed Streams

There are 10 assessment units and 108 miles of streams considered unassessed in the 2012 Integrated Report and Draft 2014 Integrated Report. From 2012-2016, samples were collected from 8 of these assessment units that will be assessed for the 2016 Integrated Report. Another 2 assessment units still need sampling and are proposed as BURP sites for 2017. Please see table below and attached map where unassessed streams are in red.

Unassessed Lake

In the 2012 draft Integrated Report, Revett Lake was added to the list of waterbodies in the report. The assessment unit number is ID17010301PN005_02L and the lake is 16 acres in surface area. It is currently unassessed. A strategy should be developed to eventually assess Revett Lake and WAG input will be very helpful during that process.
